The Commission Staff has reviewed the application in the above case. This filing is rejected for the reason set forth below.

Filing deficiency pursuant to:

- (1) 807 KAR 5:001: Section 4(4) – A person shall not file a paper on behalf of another person, or otherwise represent another person, unless the person is an attorney licensed to practice law in Kentucky or an attorney who has complied with SCR 3.030(2). An attorney who is not licensed to practice law in Kentucky shall present evidence of his or her compliance with SCR 3.030(2) if appearing before the commission. The application must be submitted by an attorney as per 807 KAR 5:001, Section 4(4).

While it is not a filing requirement, Commission Staff recommends that the Applicant file a copy of the Harrison County Sanitation District's contract with Professional Wastewater Services, LLC when filing the documents to cure deficiency. Additionally, the application references as attachments Exhibits "A", "B", and "C" and these exhibits are not attached to the application. Please provide the attachments.

The statutory time period in which the Commission must process this case will not commence until the above-mentioned required information is filed with the Commission. You are requested to file this information within 10 days of the date of this letter.
