**APPLICATION FOR APPROVAL OF TRANSFER**

Pursuant to KRS 278.020(6), Harrison County Sanitation District ("HCSD") hereby submits to the Public Service Commission of Kentucky ("Commission") this application for the transfer to HCSD of the Cedarbrook Subdivision Wastewater Treatment Plant and Collection System and Appurtenances ("CSWTP") serving the Cedarbrook Subdivision in Harrison County, Kentucky. In support of their application, the HCSD states the following:

1. The waste water treatment plant currently has no owner as RA Williams Construction Co., Inc., was permitted to abandon said plant by order of the Kentucky Public Service Commission dated May 1, 2015, in Case #2014-00091, which is attached hereto and labeled as exhibit "A". Said waste water treatment facility is currently in receivership with Franklin Circuit Court and HCSD was appointed receiver of said facility by order of Franklin Circuit Court dated May 1, 2015. A copy of said order is attached and labeled as exhibit "B". Pursuant to agreement of R.A. Williams Construction Co., Inc. and HCSD, all assets of said plant were assigned and transferred to HCSD. The terms of said agreement are also contained in an order dated May 1, 2015, Franklin Circuit Court, Civil Action #15-CI-00417.

2. HCSD is a public body corporate created and organized pursuant to KRS Chapter 76 of the Kentucky Revised Statutes by ordinance #284 of the Harrison County Fiscal Court
