AIRVIEW UTILITIES, LLC'S ANSWERS TO ATTORNEY GENERAL'S SECOND REQUEST FOR INFORMATION

Comes Airview Utilities, LLC ("Airview"), by counsel, and for its Answers to the

Attorney General's Second Request for Information, states as follows:

INFORMATION REQUEST NO. 1: Reference Airview's response to AG 1-1(b)

and (c) to answer the following questions:

a. Provide copies of the Kentucky Secretary of State's certificates of existence and authorization for Lake Columbia, LLC, Brocklyn Utilities, LLC, Coolbrook Utilities, LLC, and Fox Run Utilities, LLC.

ANSWER: Airview Utilities does not have the requested certificates of existence and

authorization. However, these documents are available on the Secretary of State's website.

b. Do the member owners of Airview, Lawrence W. Smither and Martin G. Cogan, own any other wastewater treatment plant/sewer utilities separate and independent of each other? If so, have any of these utilities been abandoned? Explain in full detail.

ANSWER: No.

INFORMATION REQUEST NO. 2: Reference Airview's response to AG 1-1(d).

Advise whether Airview or the City of Elizabethtown performed studies, or used any other method to determine the monetary cost of connecting the Airview neighborhood to

PUBLIC SERVICE COMMISSION Elizabethtown's sewer system. If yes, then provide copies of all documentation and studies that have been performed. If not, explain why a study or other method has not been performed to determine the costs.

ANSWER: Airview has not conducted a study of the cost to connect the Airview sanitary sewer system to the City of Elizabethtown sanitary sewer system. Airview has not been provided with any study prepared by the City of Elizabethtown and does not know if the City of Elizabethtown has done a detailed study. Airview has not contracted for such a study because it does not have sufficient funds to pay an engineer to draft the plans and provide an estimated cost to implement the construction needed to connect the Airview sanitary sewer system to the Elizabethtown sewer system. Furthermore, the City of Elizabethtown has not decided whether it will take ownership of the Airview WWTP and collection system.

INFORMATION REQUEST NO. 3: Reference Airview's response to AG 1-2(a) to answer the following questions:

 Explain in full detail why Hardin County Water District No. 2 refused to provide billing/collection services for Airview.

ANSWER: Airview does not know the reasons why Hardin County Water District No. 2 refused to provide the requested billing/collection services for Airview.

- b. Airview states that, "[p]ackage treatment plants were designed to be a temporary remedy to provide wastewater treatment services to its customers until service could be provided on a permanent WWTP."
 - i. Provide documentation supporting this assertion.

ANSWER: See page 2 of the minutes of the August 24, 2016 meeting of the Interim

Joint Committee on Local Government. (Attachment A.)

ii. What permanent wastewater treatment plant was envisioned for the Airview neighborhood? Explain in full detail.

ANSWER: Airview did not develop the Airview neighborhood and does not know if the original developer thought far enough in advance to envision permanent wastewater treatment for the Airview neighborhood.

iii. Were the member owners of Airview supposed to provide the permanent wastewater treatment plant alluded to in the prior statement? Explain in full detail.

ANSWER: No. Airview did not take over the operation of the Airview wastewater

treatment plant until 2005. The Airview WWTP was constructed in approximately 1969.

INFORMATION REQUEST NO. 4: Reference Airview's response to AG 1-2(b), Attachment A, to answer the following questions:

a. Provide a detailed explanation of the Auto Expense category, the cost components included in this category, and to what entity/person the payments were made.

ANSWER: No answer is required.

b. Provide a detailed explanation of the Bad Debt Expense category, the cost components included, and why there are large variances in expense amounts between 2013 and 2015.

ANSWER: The Bad Debt Expenses reflect the amount of customer delinquencies that

have been written off because they are uncollectable. Airview relies upon its accountant, Pat

Logsdon of Strothman and Company to determine the amount of bad debts to be written off.

c. Provide a detailed explanation of the Bankcard Charges category, as well as the cost components included in this category.

ANSWER: No answer is required.

d. Provide a detailed explanation of the Management category, the cost components included, and to what entity/person the payments were made.

ANSWER: The management fee is the amount that is to be paid to manage the WWTP. The calculations in the 2014 rate case authorized a management fee of \$3,600.00, but this amount has been paid. The variance in the amount of management fee actually paid is due to the fact that there are insufficient funds to pay this Fee.

e. Provide a detailed explanation of the Sludge Hauling category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2015.

ANSWER: The Sludge Hauling category represents the cost to remove and haul sludge from the digester of the WWTP. The sludge hauler charges Airview for the cost of removing and hauling the sludge to a treatment facility, and the cost of treatment is included in the charge. Airview uses either Okalona Septic Service or Headden Septic Tank Service to remove and haul the sludge. Variances in the amount of sludge hauled are due to weather conditions, the amount of inflow and infiltration, temperature, and other factors. For example, more sludge is generated in warm weather than in cold weather.

f. Provide a detailed explanation of the Continuing Education category, and the cost components included in this category.

ANSWER: No answer is required.

g. Provide a detailed explanation of the Lab Testing category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.

ANSWER: Airview is required by its KPDES permit to test the discharge from the WWTP on a weekly basis, and it retains an independent laboratory to perform this service. The name of the laboratory is Microbac Laboratory "Microbac"). Microbac Laboratory collects the samples, analyzes the samples and enter the results on the net discharge monitoring report

("DMR"). Variances in amounts paid result from when the payments to Microbac were made, as well as in performing additional analysis when required.

h. Provide a detailed explanation of the Chemicals category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.

ANSWER: A substantial amount of chemicals are used in the WWTP process, including chemicals for disinfection of the final influent (chlorine). The chemicals are purchased from Brenntag, with an office in Louisville and other locations. The variance in the cost of chemicals is due to increases in the cost of chemicals and the use of a new vendor. The prior chemical vendor was Chemical Resources out of Louisville, Kentucky.

i. Provide a detailed explanation of the Rent Expense category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2014 through 2016.

ANSWER: The Rent Expense category accounts for the rent paid to the landlord for Airview's office located on Taylorsville Road. Airview has had the office for approximately one and one-half years, and the rent component was first approved by the Public Service in the 2014 rate-case.

j. Provide a detailed explanation of the Utilities category, the cost components included, and to what entity/person the payments were made.

ANSWER: Airview purchases water from Hardin County Water District No. 2, and electricity from Nolin Rural Electric.

k. Provide a detailed explanation of the Plant Operator category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016. **ANSWER:** The Plant Operator category reflects the payments made to the individual that operates the WWTP. Variances in the amounts paid are due to financial condition of Airview. The Plant Operator has been Shawn Ford for the relevant time period.

 Provide a detailed explanation of the Treatment System Maintenance category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.

ANSWER: The Treatment System Maintenance category reflects the cost to repair and/or replace the equipment in the WWTP. Variances are due to when the equipment needs to be repaired or replaced as a result of normal operations, breakdowns or vandalism. Variances are a result from when Airview is able to make payment. The payments were made to Covered Bridge and to vendors where parts were purchased and/or repaired, including Quality Electric (repaired the gear drive), Masters Supply, etc.

- m. Provide a detailed explanation of the Collection Expense category, the cost components included, and to what entity/person the payments were made.
- **ANSWER:** No answer is required.
 - n. Provide a detailed explanation of the Office category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.
- **ANSWER:** Answer to be provided.
 - o. Provide a detailed explanation of the Bank and Merchant Charges category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.
- **ANSWER:** Answer to be provided.

p. Provide a detailed explanation of the Customer Invoicing category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.

ANSWER: The Customer Invoicing category reflects the cost to perform the billing and collection services for Airview. The payments were made to Integrity Bookkeeping. Variances in the amounts paid are due to the financial condition of Airview.

q. Provide a detailed explanation of the Legal and Professional fees category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.

ANSWER: This category reflects payments made for legal services, accounting services and services to prepare and file the rate case in 2014. The payments were made to Strothman and Company (accountant Pat Logsdon), Hazelrigg & Cox, LLP (attorneys fees) and Stites & Harbison PLLC (attorneys fees), and Kentucky Small Utilities Consulting, LLC (rate case consulting). Variances in the amounts paid are due to the financial condition of Airview, the filing of a rate case, when responses to environmental issues are required, etc.

r. Provide a detailed explanation of the Supervision category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2015.

ANSWER: Answer to be provided.

s. Provide a detailed explanation of the Tier II Emergency Fee category, the cost components included, and to what entity/person the payments were made.

ANSWER: No Answer is required.

t. Provide a detailed explanation of the Insurance category, the cost components included, and to what entity/person the payments were made.

ANSWER: Answer to be provided.

u. Provide a detailed explanation of the Miscellaneous: Storage, Damage Claim category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.

ANSWER: This category reflects the amounts paid to repair equipment and the

storage building, that were damage and/or destroyed by vandalism.

v. Provide a detailed explanation of the Tax category, the cost components included, to what entity/person the payments were made, and why there are large variances in expense amounts between the years 2012 through 2016.

ANSWER: Answer to be provided.

w. Provide a detailed explanation of the Loans category, the cost components included, what entity/person provided the loan to Airview, copy of all loan documents, reason for the loans, and whether or not each loan complied with KRS 278.300 which requires Commission approval of utility indebtedness, with minor exceptions.

ANSWER: See Answer to Information Request Nos. 5(a), and 5(e)

x. Provide a detailed explanation as to the variance of the total expenses to operate the treatment plant from 2012 through 2016. For example, in 2012 the total expenditures were \$64,958.51 while in 2013 the expenditures were \$90,970.63.

ANSWER: The variance in total expenses results from the variation in the individual expense categories, and whether Airview has the financial resources to pay the expenses.

INFORMATION REQUEST NO. 5: Reference Airview's response to AG 1-2(d),

Attachment B, that provides all of Airview's creditors and outstanding debts to answer the following questions:

- a. Brocklyn Utilities, currently owed \$4,950:
 - i. Provide a copy of any and all note/loan agreements between Airview and Brocklyn Utilities.

ANSWER: There are no written loan agreements between Airview and Brocklyn Utilities.

ii. Provide the name of the owner(s) of Brocklyn Utilities.

ANSWER: Lawrence W. Smither and Martin G. Cogan are the members of Brocklyn Utilities.

iii. Provide a full explanation as to whether a conflict of interest exists between Brocklyn Utilities and Airview.

ANSWER: Objection. Airview objects to this request as it is ambiguous and requires speculation as to its meaning. Furthermore, it requests information that is irrelevant to this proceeding and is not likely to result in the discovery of relevant evidence. Without waiving this objection, Airview states that it does not believe that a conflict of interest exists.

- iv. Did Airview request the Commission's permission before entering into loan agreement(s) with Brocklyn Utilities? If so, provide the case number(s). If not, explain how the loan did not violate KRS 278.300 which requires Commission approval of utility indebtedness with minor exceptions.
- ANSWER: No, permission was not required pursuant to KRS 278.300(8).
 - b. Covered Bridge Utilities, currently owed \$39,950.56:

i. Provide a copy of any and all invoices regarding the outstanding debt, and note/loan agreements between Airview and Covered Bridge Utilities, if any.

ANSWER: There are no loan agreements between Airview and Covered Bridge Utilities. The outstanding invoices are attached as Attachment B.

- ii. Provide the name of the owner(s) of Covered Bridge Utilities.
- **ANSWER:** Lawrence W. Smither.
 - iii. Provide a full explanation as to whether a conflict of interest exists between Covered Bridge Utilities and Airview.

ANSWER: Objection. Airview objects to this request as it is ambiguous and requires speculation as to its meaning. Furthermore, it requests information that is irrelevant to this proceeding and is not likely to result in the discovery of relevant evidence. Without waiving this objection, Airview states that it does not believe that a conflict of interest exists because if Covered Bridge did not perform the work, Airview would have a very difficult time in obtaining any contractor due to the significant delay in payment.

iv. Did Airview issue a request for proposal (RFP) for any of the work performed by Covered Bridge Utilities including but not limited to the repairs/maintenance and/or the remote lift station? Provide a copy of all bids Airview received by Covered Bridge Utilities, and indicate whether or not it was the lowest cost bid. If Airview did not request bids, explain in full detail why not.

ANSWER: No.

v. If any loans exist, did Airview request the Commission's permission before entering into a loan agreement(s) with Covered Bridge Utilities? If so, provide the case number. If not, explain how the loan did not violate

KRS 278.300 which requires Commission approval of utility indebtedness with minor exceptions.

ANSWER: No loans have been made to Airview by Covered Bridge.

- c. Shawn Ford, currently owed \$12,950.00:

ANSWER: Shawn Ford is paid by Airview on a monthly basis to operate the Airview WWTP. Mr. Ford is not required to submit an invoice to Airview, as his monthly pay is a fixed amount.

ii. Provide the name of the company that Shawn Ford is employed by, as well as the name of the owner(s) of this company.

ANSWER: Mr. Ford is self-employed when conducting work for Airview.

iii. Provide a full explanation as to whether a conflict of interest exists between Shawn Ford and/or his employer and Airview.

ANSWER: Objection. Airview objects to this request as it is ambiguous and requires

speculation as to its meaning. Furthermore, it requests information that is irrelevant to this

proceeding and is not likely to result in the discovery of relevant evidence. Without waiving this

objection, Airview states that it does not believe that a conflict of interest exists.

iv. Did Airview issue a request for proposal (RFP) for any of the work performed by Shawn Ford? Provide a copy of all bids Airview received by Shawn Ford, and indicate whether or not it was the lowest cost bid. If Airview did not request bids, explain in full detail why not.

ANSWER: No.

d. Hazelrigg & Cox, LLP, currently owed \$3,485.28:

i. Provide a copy of any and all invoices submitted by Hazelrigg & Cox to Airview Utilities regarding the outstanding debt.

Utilities.

- ANSWER: The members of Coolbrook Utilities are Lawrence W. Smither and Martin G. Cogan.
 - iii. Provide a full explanation as to whether a conflict of interest exists between Coolbrook Utilities and Airview.

ANSWER: Objection. Airview objects to this request as it is ambiguous and requires speculation as to its meaning. Furthermore, it requests information that is irrelevant to this proceeding and is not likely to result in the discovery of relevant evidence. Without waiving this objection, Airview states that it does not believe that a conflict of interest exists.

iv. Did Airview request the Commission's permission before entering into loan agreement(s) with Coolbrook Utilities? If so, provide the case number(s). If not, explain how the loan did not violate KRS 278.300 which requires Commission approval of utility indebtedness with minor exceptions. **ANSWER:** No, permission was not required pursuant to KRS 278.300(8).

Furthermore, it requests information that is irrelevant to this proceeding and is not likely to result in the discovery of relevant evidence. Without waiving this objection, Airview states that it does not believe that a conflict of interest exists.

- h. Hornback Plumbing, currently owed \$476.00:
 - i. Provide a copy of any and all invoices submitted by Hornback Plumbing to Airview Utilities regarding the outstanding debt.
- **ANSWER:** No invoices are available.
 - i. Stites & Harbison, PLLC, currently owed \$3,536.60:
 - Provide a copy of any and all invoices submitted by Stites & Harbison,
 PLLC to Airview Utilities regarding the outstanding debt.
- ANSWER: See Attachment F.
 - ii. Provide a detailed explanation of what work was performed in conjunction to the outstanding debt.
- **ANSWER:** See Attachment F.
 - j. Strothman & Co, CPA, currently owed \$2,400.00:
 - i. Provide a copy of any and all invoices submitted by Strothman & Co, CPA regarding the outstanding debt.
- **ANSWER:** See Attachment G.
 - ii. Provide a detailed explanation of what work was performed in conjunction to the outstanding debt.
- **ANSWER:** See Attachment G.
 - k. Kentucky State Property Tax, currently owed \$299.66:

i. Provide a copy of Airview's tax bill.

ANSWER: See Attachment H.

1. Instead of taking multiple loans and going into debt of \$90,213.10, why did Airview not file a rate or abandonment case previously?

ANSWER: Airview made every effort to avoid filing this abandonment case with the Public Service Commission. It filed a rate case with the Public Service Commission in 2014. However, the increase in its rate authorized by the Public Service Commission did not provide sufficient monies to pay for the operation of the WWTP, as it is unable to collect all of the amounts due from its customers. Airview also attempted to negotiate the sale and/or transfer of the Airview WWTP and collection system to the City of Elizabethtown, Hardin County Water District No. 1 and Hardin County Water District No. 2, but was unsuccessful in doing so. Accordingly, the decision was made to file the abandonment case.

m. Explain in full detail whether any of the entities/person(s) owed money by Airview intend to request a surcharge, file an action for involuntary bankruptcy, or take any other legal action to collect the debts against Airview, the potential receiver, and/or its ratepayers?

ANSWER: Airview is not aware of whether any of the entities/person(s) owed money by Airview intend to request a surcharge, file an action for involuntary bankruptcy, or take any other legal action to collect the debts against Airview, the potential receiver and/or its ratepayers.

n. Do the member owners of Airview, Lawrence W. Smither and Martin G. Cogan, receive tangible or intangible compensation from any of the companies that are creditors listed in Attachment B?

ANSWER: When monies are available, Lawrence W. Smither and Martin G. Cogan receive compensation from Coolbrook Utilities, and Brocklyn Utilities. Lawrence W. Smither receives compensation from Covered Bridge Utilities.

INFORMATION REQUEST NO. 6: Reference Airview's Application generally.

Provide a list of all Airview employees with position title, in addition to yearly salary for the past five (5) calendar years, raises, benefits, bonuses, etc.

ANSWER: Airview has no employees.

INFORMATION REQUEST NO. 7: Reference Airview's response to AG 1-2(g)

and Attachment C to answer the following questions:

a. Explain in full detail the status of the Energy and Environment Cabinet's ("EEC") Administrative Complaint filed against Airview on February 24, 2016. Include any and all costs already incurred associated with this enforcement action, including but not limited to legal costs, penalties, and compliance measures.

ANSWER: An answer has been filed to the administrative complaint filed against

Airview. Discovery has not yet begun. The next status conference in the case is scheduled for

December 8, 2016. The parties are focusing their efforts on encouraging the City of

Elizabethtown to take over the plant. See also Attachment F.

- b. In the event that the PSC grants Airview's request to abandon, will Airview's member owners retain responsibility to pay any penalties imposed from the EEC's Administrative Complaint?
- ANSWER: Unknown.
 - c. Will Airview continue to maintain responsibility for any legal fees incurred in defending against the EEC's Administrative Complaint?

ANSWER: Unknown.

INFORMATION REQUEST NO. 8: Reference Airview's response to AG 1-3(a). Are the Airview ratepayers refusing to make payment due to poor service? Provide the number of customer complaints that Airview received from ratepayers for the years 2012 – 2016. **ANSWER:** Airview does not believe that its ratepayers are refusing to make payment due to poor service.

INFORMATION REQUEST NO. 9: Reference Airview's response to AG 1-3(b). Provide the dates during which Airview utilized Credit Solutions, LLC as a collection agency, and any documentation that demonstrates the inability of Credit Solutions to collect on delinquent accounts.

ANSWER: Airview will provide the dates Credit Solutions, LLC was used as a collection agency. See Attachment A to the Answers of Airview Utilities, LLC to the Attorney General's data requests which reflects the amount of bad debt written off by Airview in 2015, 2014 and 2013.

INFORMATION REQUEST NO. 10: Reference Airview's response to AG 1-4(a) and (b), as well as Attachment D to answer the following questions:

a. Airview asserted that its monthly expenses were \$7,780.70, and it received \$8,262.89 in monthly revenue based on the last seven months of operations. If this is the case, why does Airview continuously state that it takes in less revenue than the cost to operate the wastewater treatment plant?

ANSWER: See Airview's supplement to its answers to the Attorney General's data requests which establishes that its monthly receipts are less than its monthly income.

b. Refer to Airview's response to PSC 1-7 where Airview states that the average monthly operating cost is \$8,400.81. However, Airview stated in response to AG 1-4(a) and (b), Attachment D that the monthly expenses were \$7,780.70. Explain in full detail the discrepancy between the answers to the PSC and the Attorney General's Office.

ANSWER: See Airview's supplement to its answers to the Attorney General's data requests which establishes that its monthly receipts are less than its monthly income.

INFORMATION REQUEST NO. 11: Reference Airview's response to AG 1-5(a), (b), and (c). Provide a detailed status update on Airview's discussions with other entities to own and/or operate the Airview wastewater treatment plant and collection system. Provide a copy of the contract if one has been entered, as well as the monthly fee that will be imposed on the ratepayers.

ANSWER: Airview continues to engage in discussions with the City of Elizabethtown to see if it will take over the ownership and operation of the Airview wastewater treatment plant and collection system. The difficulty in obtaining a funding source to pay for the cost to connect the Airview Utilities sanitary sewer system to the City of Elizabethtown sanitary sewer system needs to be overcome. No contract has been prepared or executed.

INFORMATION REQUEST NO. 12: Reference PSC 1-16 where Airview states that if abandonment is authorized then Airview will turn over the wastewater treatment plant and collection system to the Receiver appointed by the Franklin Circuit Court. Reconcile this statement with Airview's response to PSC 1-14 where the Company asserts that it intends to sell the wastewater treatment plant, related equipment, and the real property it sits upon in order to pay outstanding debts.

Airview would prefer that any entity taking over the system take ownership of all of the assets. However, if Airview owns the WWTP and related equipment after any transfer of the system because the entity taking over the collection system does not want to take ownership of the WWTP and related equipment, it will attempt to sell these items to generate funds to pay its creditors.

ANSWER: It is unknown whether the entities/persons that are owed money by Airview would be willing to accept less than the full amount.

Call to Order and Roll Call

Approval of Minutes

Upon the motion of Representative Tipton and a second by Representative Crimm, the minutes of the June 22, 2016 meeting were approved.

Regarding the topic of package sewer treatment plant abandonment, Senator Bowen stated that, for various reasons, owners of package sewer treatment plants sometimes become unable to run the plants and then may cease operations without provision for continuance of sewage treatment. This places the users in a precarious position and can put pressure on city and county resources to try to fill the gap left by abandonment. Spurred by this situation, 2016 HB 261 was passed which puts in place fiscal safeguards for future package sewer locations and the subsequent approval by the Public Service Commission. In addition, it also places notice requirements of the prospective utility's location to state and local governments, as well as the Attorney General.

The issue of bio-digester location is got its prominence recently in Louisville with the potential location of a bio-digester plant within Louisville Metro. A bio-digester unit takes waste materials and processes them, producing methane. During the past winter, Louisville was dealing with the potential location of a bio-digester in the West End. Louisville Metro placed a six-month moratorium on the location until a policy could be established to provide for the location of the units in a deliberate way. While this has most recently been an issue in Louisville Metro, it has application throughout Kentucky.

Representative Riggs commented that the committee needs to be updated on these two issues. He also encouraged them to tour the Muhammad Ali Center and attend the State Fair while in town.

Package Sewer Treatment Plant Abandonment

Mr. Peter Goodmann, Director of the Division of Water (DOW), said that DOW implements most of Kentucky's water regulatory programs, including the Clean Water Act. DOW regulates package wastewater treatment plants (WWTPs) via Clean Water Act discharge permits that require dischargers to meet technology and water quality-based standards. Package plants are operated by private utilities or are owned by neighborhood associations, school boards, or other entities, including the Kentucky Transportation Cabinet at state interstate rest stops. Package plants serve housing developments, subdivisions, mobile home parks, apartment buildings, campgrounds, and small businesses, and are generally located away from municipalities and other regional wastewater treatment collection and treatment facilities.

There are between 500 and 600 package WWTPs with Clean Water Act discharge permits. Thirty to sixty are regulated by the Public Service Commission (PSC). Most package plants date to the 1970s and 1980s and have significantly exceeded their design life. Older, poorly-maintained infrastructure leads to poorer treatment and lower quality of effluent, which leads to water quality and public health problems. These plants sometimes have aesthetic issues. They can become inundated with ground water because of cracked piping, and can be inundated with other sources of water inflow, such as that from sump-pumps. They often have trouble conducting advanced treatment to meet modern standards.
