RE: Informal Conference of September 6, 2016

Pursuant to Commission Staff's ("Staff") Notice of Informal Conference filed into the record on September 1, 2016, an IC was held in this matter on September 6, 2016. A copy of the sign-in sheet is attached hereto.

During the informal conference, Mr. Spenard stated that Staff would prepare minutes of the informal conference for the case record, that a copy of the minutes would be entered into the record, and that the parties would have an opportunity to submit written comments upon the minutes. Mr. Spenard stated that the views of Staff are not binding on the Commission.

Staff discussed portions of the Kentucky-American Water Company ("KAWC") and Classic Construction, Inc. ("Classic") responses to Staff's First Request for Information ("Staff's First Request"). Staff asked KAWC to supply additional detail concerning the journal entries that KAWC will use to record the acquisition of the assets of Classic. KAWC stated that it would file the information sought by Staff into the record through a supplemental response to Staff's First Request containing a work paper for the journal entries and also detail supporting the derivation of the \$31,250 amount for Accrued Waste Disposal. KAWC stated that it would file the material within one week.

There being no further business, the informal conference was adjourned.
