Call before you dig

Know what's below

If your fall projects require diggingsuch as planting trees or shrubs, or setting posts-please stop and dial 811 first.

Underground utilities, such as buried gas, water, and electric lines, can be a shovel thrust away from turning a fall project into a disaster.

Play it safe by dialing 811 to find out



where utility lines run on your property. Your call will

be routed to a local "one call" center. Tell the operator where you're planning to dig and what type of work you will be doing, and affected local utilities will be notified.

In a few days, a locator will arrive to designate the approximate location of any underground lines, pipes, and cables. These areas will be marked with flags or paint so you will know where it's safe to dig.

Although many homeowners tackling do-it-yourself digging projects are aware of "Call Before You Dig"

services, over 50 percent of people do not take advantage

of the service according to Common Ground Alliance (CGA), a federally mandated group of underground utility and damage prevention industry professionals. CGA data also shows that an underground utility line

is damaged every six minutes in the U.S. because someone decided to dig without first dialing 811.

Even simple tasks like installing a new mailbox post can damage utility lines, which can disrupt service to an entire neighborhood, harm diggers, and potentially result in fines and repair costs.

Never assume the location or depth of underground utility lines. The 811 service is free, prevents the inconvenience of having utilities interrupted, and can help you avoid serious injury. For more info: www.811.com.
