JOINT MOTION TO HOLD IN ABEYANCE

COMMONWEALTH OF KENTUCKY

BEFORE THE PUBLIC SERVICE COMMISSION OF KENTUCKY

10 Big Rivers Electric Corporation ("Big Rivers"), the City of Henderson, Kentucky, and the Henderson Utility Commission, d/b/a Henderson Municipal and 11 Power & Light (together, "Henderson," and collectively with Big Rivers, the 12 "Parties") jointly move the Public Service Commission ("Commission") to enter an 13 14 order holding in abeyance further proceedings in this matter to permit the Parties 15 to explore resolution of the issues presented in this case. The hearing in this matter was held February 7, 2017, and the only remaining procedural step is for the 16 Commission to reach a decision and enter its order. The Parties state that they 17 18 believe their ability to resolve a number of disputes among them, including but not limited to the dispute that is the subject of this proceeding, will be improved if the 19 Commission holds these proceedings in abevance until July 20, 2017. The Parties 20 further believe that holding this matter in abeyance, as requested, will be in the 21 22 best interests of the Parties, and offers an opportunity for this case to be resolved without further expenditure of time by the Commission. 23

1	Henderson expressly states that it joins in this motion without waiving its
2	argument that the Commission lacks jurisdiction to hear the issues presented in
3	this case, and does not submit to Commission jurisdiction by joining in this motion
4	to hold in abeyance.
5	Wherefore, the Parties move that the Commission enter an order holding this
6	matter in abeyance for a period ending July 20, 2017, and for all other relief to
7	which the Parties appear entitled.
