RE: Informal Conference of September 28, 2016

Pursuant to the Commission's September 16, 2016 Order, an informal conference was held in this matter on September 28, 2016. Attached is a copy of the attendance roster.

Commission Staff began the meeting by stating that the purpose of the conference was to discuss the show cause proceeding against Kentucky Power Company ("Kentucky Power"). Giving rise to the show cause proceeding is the July 12, 2014 incident involving Jason Michal Grace.

Commission Staff and Kentucky Power discussed the incident, including remedial measures taken by Kentucky Power to address safety concerns. Commission Staff requested that Kentucky Power file documentation of its remedial measures into the record within ten days. Commission Staff and Kentucky Power reached an agreement in principle and will prepare to draft a Stipulation Agreement.

There being no further issues to discuss, the conference was adjourned.
