Application of Big Rivers Electric Corporation for Approval of Amendment

to Stipulation and Recommendation

Pursuant to the Commission Staff's ("Staff") Notice of August 26, 2016, a telephonic informal conference was held on August 26, 2016, at the Commission's offices in Frankfort, Kentucky. The purpose of the informal conference was to discuss Big Rivers Electric Corporation's ("Big Rivers") application for approval of an Amendment to the Stipulation and Recommendation that was approved by the Commission in Case Nos. 2014-00230¹ and 2014-00455.² A list of the attendees is attached hereto.

Staff referenced paragraph 7 of the application, which states that "[u]nder the Stipulation and Big Rivers' current FAC tariff, the last credit will apply to the October 2016 service month." Staff stated that while the statement accurately reflects the Stipulation, it is not true for Big Rivers' current tariff. Staff noted that Big Rivers' current tariff allows the credit through the January 2017 service month, which would take into account the December 2016 expense month.

Upon inquiry from Staff, Big Rivers' representatives indicated that the term "service month" as used in the application, e.g., "August 2015 service month," is synonymous with its use of the term "consumption" in the application, e.g., "November 2015 consumption." Big Rivers further confirmed that use of both terms indicates a one month lag in the expense month. Thus, an August 2015 service month would mean a July expense month and a November 2015 consumption would mean an October expense month.

Upon inquiry from Staff regarding the mechanics of paragraph 1(d) of the Amendment,³ Big Rivers stated that its goal is to ensure that at least three payments would be made subsequent to any voluntary change made by Big Rivers to its fuel cost allocation methodology.

Lastly, Staff pointed out that counsel for Kentucky Industrial Utility Customers, Inc. inadvertently signed on the signature line reserved for the Attorney General of Kentucky, by and through his Office of Rate Intervention. Big Rivers' counsel indicated that he would provide a corrected signature page and file the same within the next few days.

There being no further discussions, the informal conference was adjourned.
