**MOTION FOR EXPEDITED APPROVAL**

Pursuant to Section 252(e)(1) of the Telecommunications Act of 1996 (the "Act"), 47 U.S.C. 252 (e)(1), Peoples Telecom, LLC ("PTC"), through its undersigned counsel, hereby requests expedited approval of its adoption of a negotiated interconnection agreement between Windstream Kentucky East, LLC<sup>1</sup> ("Windstream") and PTC.

PTC is a utility within the meaning of KRS 278.010(3)(e) and is a competitive local exchange carrier authorized to provide service in Kentucky. Windstream is an incumbent local exchange carrier or ILEC.

Pursuant to Section 252 (i) of the Act, PTC adopted the terms of the Interconnection Agreement ("Adoption") between Windstream and CenturyLink Communications, LLC ("CLC") that was approved by the Kentucky Public Service Commission as an effective Agreement (the "Agreement") in the Commonwealth of Kentucky. That agreement was filed under PSC Reference No. 01174 and became effective on July 17, 2016.

PTC's Adoption was filed August 9, 2016 (PSC Reference Number 01180) and by letter issued August 12, 2016, the Commission indicated that Agreement was compliant federal and state law and with previous Commission orders. Accordingly, pursuant to 47 U.S.C. 252, the agreement shall be effective on November 7, 2016.<sup>2</sup>

Absent affirmative Commission action the Adoption becomes "approved" only by operation of federal law, after the 90 day period described in Section 252(e)(4) of the Act. However, PTC intends to operate using the Agreement as soon as possible pursuant to an arrangement already effective. Accordingly, PTC requests that the Commission issue an order approving the negotiated agreement. Such order will expedite PTC's expansion in the Kentucky market.
