Comes North Mercer Water District, hereinafter the District, by Counsel, and moves the Public Service Commission, hereinafter the Commission, to hold an informal conference relating to the Complaint set out in Public Service Commission Case No. 2016-00154, and the procedure followed in Public Service Commission Case No. 2016-00310, and the District further moves to grant a stay of the appeal time following the Order in said Case No. 2016-000310, pending the informal conference.

In support of these Motions, the District states that this District did not receive adequate, if any, notice of the Commission's proceedings.

The District specifically notes that Michelle Lee, District Manager, the liaison person between the District and the Commission, has not been properly contacted regarding these proceedings. The Commission, through its staff, has attempted, unsuccessfully, to

communicate with Ms. Lee through the internet service provider, Burgin Wireless, at mnwd@burginwireless.com. Burgin Wireless went out of business in 2008. The District's correct e-mail is mlee@northmercerwater.org.

The Commission was originally notified of the correct electronic mail address in 2008, and the Commission and the District have had innumerable electronic mail communications, regarding tariffs, customer complaints, inspections, and training using the correct address.

In further support of theses motions, the District, by Counsel, states that Thomas M. Jones, attorney for the District, has received no Notice regarding the subject cases, despite entering his appearance on behalf of the District by filing a Motion for an Extension.

The Commission should be advised that the District totally disagrees with the narrative presented by Ronald D. McGinnis. Mr. McGinnis has stated, as reported by Virginia Smith, that the District would charge him \$250.17 plus \$702.00 as a new deposit and reconnect fee. In fact, the District would charge Mr. McGinnis \$240.29 for water used and the appropriate tax; \$10.50 for the broken lock on the meter; \$30.00 as service fee to replace the meter back in the pit, for a total of \$280.79. The District disagrees with other statements made by Mr. McGinnis.

Because of the difficulties discussed above, the undersigned requests that all future communication regarding these matters be in writing through the U.S. Postal Service.
