ORDER

On April 20, 2017, Louisville/Jefferson County Metro Government ("Louisville Metro") filed a motion requesting the Commission to compel Louisville Gas and Electric Company ("LG&E") to respond to two items in Louisville Metro's request for information filed on March 24, 2017. Louisville Metro also requests a temporary suspension of the existing procedural schedule so it can receive and analyze the outstanding information prior to filing its rebuttal testimony.

Based on the motion and being otherwise sufficiently advised, the Commission finds that while the record is not sufficiently developed to adjudicate Louisville Metro's motion to compel, it is reasonable to suspend the due date of April 21, 2017, for each party to file rebuttal testimony as established by the procedural schedule appended to our February 27, 2017 Order. Upon our final determination of Louisville Metro's motion to compel, a new due date will be established for the filing of rebuttal testimony.

IT IS THEREFORE ORDERED that:

The procedural schedule appended to the Commission's February 27, 2017
Order is amended to the limited extent that the April 21, 2017 due date for the parties to

file rebuttal testimony is suspended and a new due date shall be established by further Order of the Commission.

All other provisions of the Commission's February 27, 2017 Order shall remain in full force and effect.
