Pursuant to the Commission's October 6, 2016 Order, an informal conference was held in this matter on October 14, 2016. Attached is a copy of the attendance roster.

Commission Staff began the meeting by stating that the purpose of the conference was to discuss the show cause proceeding against Kenergy Corp. ("Kenergy"). Giving rise to the show cause proceeding is the October 4, 2014 incident involving Kenergy employee, Rhyan Dickerson.

Commission Staff and Kenergy discussed the incident, including any remedial measures taken by Kenergy to address safety concerns. Commission Staff and Kenergy failed to reach an agreement in principle and will prepare to go to a hearing as scheduled in this matter for November 29, 2016.
