



Request 6. Refer to the Company's response to the AG's Initial Request 4k.
a. What is the basis for the \$12,000 estimate and why does the company believe that the amount is not only reasonable, but is enough to cover the cost of the annual legal fees?

Response 6a. Martin originally responded that it had retained the services of Rose Camenisch Mains, PLLC in Lexington, Kentucky to represent Martin in the litigation with Vinland Energy. Martin also responded that Martin had paid Rose Caomenisch Mains, PLLC at total of \$16,435 with regards to the Vinland Energy litigation. However, that information was incorrect. Clean Gas, Inc., has hired Rose Camenisch Mains, PLLC to represent Clean Gas, Inc. in a separate litigation action with Vinland Energy. Martin has retained the services of Randy A. Campbell Law Offices, PSC, located in Hindman, Kentucky. Litigation can be a very lengthy process and the cost of discovery, etc., is difficult to estimate. Martin believes this litigation will take some time and impact its expenses and therefore Martin should make allowances for this legal expense. Martin has incurred legal expenses of \$750 to Randy A. Campbell Law Offices with regards to the Vinland Energy litigation.
