RE: Informal Conference of November 15, 2016

Pursuant to the Commission's November 9, 2016 Order, an informal conference was held in this matter on November 15, 2016. Attached is a copy of the attendance roster.

Commission Staff began the meeting by stating that the purpose of the conference was to discuss the show cause proceeding against Duke Energy Kentucky, Inc. ("Duke Kentucky"). Giving rise to the show cause proceeding is the April 3, 2015 incident involving Nathan Trapp and Kyle Leininger.

Commission Staff and Duke Kentucky discussed the incident, including remedial measures taken by Duke Kentucky to address safety concerns arising as a result of the April 3, 2015 incident. Commission Staff requested that Duke Kentucky file documentation of its remedial measures into the record on or by November 23, 2016. After extensive discussions, Commission Staff and Duke Kentucky were able to reach an agreement in principle. Commission Staff will draft a Stipulation Agreement setting forth the terms of the settlement. Commission Staff will forward the draft Stipulation Agreement to Duke Kentucky for review, comment, and execution.

There being no further issues to discuss, the conference was adjourned.
