LEGAL NOTICE REGARDING THE NORTH SHELBY WATER COMPANY

Notice is hereby given that because of an increase in the cost of water purchased from the Frankfort Plant IVED Board, the North Shelby Water Company will increase its rates for services effective November 1, 2016. VED An application requesting the proposed rates was filed with the Kentucky Public Service Commission on September 30, 2016 to increase rates as follows:

As noted above, based on the increased cost of water from the Frankfort Plant Board all rates will increase \$0.02 per 1,000 gallons. The monthly bill for a customer using an average of 5,000 gallons of water each month will increase from \$42.14 to \$42.24. This is an increase of \$0.10 or 0.24%.

The charges/rates contained in this notice are the charges/rates proposed by the North Shelby Water Company. However, the Public Service Commission may order charges/rates to be charged that differ from these proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rates detailed in this notice.
