Comes Nolin Rural Electric Cooperative Corporation (hereinafter referred to as "Nolin RECC") by counsel, and moves the Kentucky Public Service Commission ("Commission") for a brief, ten (10) day extension of time in which to respond to data requests in the above-captioned case, both from the Commission staff and from the Office of the Attorney General. In support of said Motion, Nolin RECC respectfully states as follows:
