Pursuant to an Order issued on April 26, 2017, granting the joint motion for an informal conference filed by Kentucky Utilities Company and Louisville Gas and Electric Company (collectively, "KU/LG&E"), an informal conference ("IC") was conducted at the Commission's offices in Frankfort, Kentucky, on April 25, 2017. Attached is a copy of the attendance roster.

The IC was held at the request of KU/LG&E for the limited purpose of the discussion and possible resolution of the issues associated with KU/LG&E's proposed Pole and Structure Attachment Charges Rate Schedule ("Rate PSA").

Representatives of KU/LG&E, AT&T Kentucky ("AT&T"), and Kentucky Cable Telecommunications Association ("KCTA") arrived at an agreement in principle for the resolution of all material issues pertaining to Rate PSA in this matter. KU/LG&E, AT&T, and KCTA will finalized the language of a stipulation agreement, and the stipulation agreement and revised red-lined Rate PSA tariff will be filed with the Commission on or before May 1, 2017. KU/LG&E intends to file testimony in support of the stipulation agreement no later than May 4, 2017.

After discussion regarding the availability of the parties' witnesses and the parties' counsel due the events scheduled prior to the rescheduled dates for the hearing, KU/LG&E, AT&T, and KCTA will provide notice setting forth the availability of the witnesses and counsel.

There being no further discussion, the IC was then adjourned.
