## ATTORNEY GENERAL'S MOTION FOR LEAVE TO FILE OUT OF TIME AND TO WITHDRAW MOTION TO SET A PROCEDURAL SCHEDULE

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and hereby moves the Commission for leave to file his Initial Requests for Information out of time and to allow him to withdraw his previously filed Motion to Set a Procedural Schedule in the above-styled matter.

The Attorney General filed his Motion to Intervene in this matter November 10, 2016, and was granted intervention by Commission order November 21, 2016. In the interim between the Attorney General requesting and being granted intervention, the Commission entered an Order in the record suspending the proposed tariff changes in this case and providing a procedural schedule. The Attorney General inadvertently missed this order in the case file, and until being told of the Commission's Order, he was unaware a procedural order existed and that the Attorney General was afforded the opportunity to conduct discovery. Due to the Attorney General's oversight of the record, he now requests the Commission allow him to file his initial data requests to the Company which were originally due November 28, 2016.

As the Attorney General's filing of these data requests is four (4) days late, he additionally requests the Commission allow Louisville Gas & Electric (LG&E) have four (4)

additional days to respond, causing the requests to be due on or before December 16, 2016. This would provide LG&E fourteen (14) days, the amount previously afforded in the procedural schedule, to respond to the Attorney General's data requests. This extension of time would not put any party at a disadvantage and will have no effect on the current procedural schedule going forward. The Attorney General has spoken to LG&E's counsel regarding this motion, and counsel stated the Company does not have an objection. Furthermore, due to fact that a procedural schedule had been set by the Commission when the Attorney General filed his Motion to Set a Procedural Schedule on November 29, 2016, he additionally requests the Commission allow him to withdraw that motion.

WHEREFORE, in view of all the foregoing the Attorney General prays the Commission grant his Motion For Leave To File Out Of Time, and to withdraw his previously filed Motion to Set A Procedural Schedule.
