East Kentucky Network, LLC d/b/a Appalachian Wireless, was granted authorization to provide cellular service in the KY-9 Cellular Market Area (CMA451) by the Federal Communications Commission (FCC). The FCC license is included as Exhibit 1. East Kentucky Network, LLC merger documents were filed with the Commission on February 2, 2001 in Case No. 2001-022. East Kentucky Network, LLC is a Kentucky Limited Liability Company that was organized on June 16, 1998. East Kentucky Network, LLC is in good standing with the state of Kentucky.

East Kentucky Network, LLC currently co-locates on an existing tower located near the proposed tower site. However, due to advancing technology, load capacity, and in an effort to improve service in Morgan County, pursuant to KRS 278.020 Subsection 1 and 807 KAR 5:001, East Kentucky Network, LLC is seeking the Commission's approval to construct a 300 foot self-supporting tower on a tract of land located near 15240 Highway 460 W, Ezel, Morgan County, Kentucky (37°54'00.88"N 83°27'13.77"W) to replace the existing tower. Upon completion of the proposed tower site, the existing tower and all corresponding structures will be removed, excepting electronic communications equipment, which will be moved to the proposed tower site. A map and detailed directions to the site can be found in Exhibit 7.
