RE: Informal Conference of December 19, 2017

Pursuant to Commission Staff's ("Staff") Notice of Informal Conference ("IC") filed into the record on December 12, 2017, an IC was held in this matter on December 19, 2017. A copy of the sign-in sheet is attached. Jeff Reynolds of HMB Engineers, Pat Price and Vernon Barton representatives from Western Fleming County Water District. ("Western Fleming"), participated by telephone in the conference.

During the conference, Ms. Koenig stated that Staff would prepare minutes of the conference to enter in the case record, and that the parties would have an opportunity to submit written comments. Ms. Koenig stated that Staff is not a party to the case and the views of Staff are not binding on the Commission.

Staff stated the history of the case, recounting the Application filed by Western Fleming on December 6, 2016, deemed deficient and Western Fleming's Supplemental Request for Deviation entered on February 3, 2017, curing the deficiency. Notice of the informal conference was filed in the record on December 12, 2017. Staff and the parties discussed the reason for the informal conference was the record does not contain facts upon which the Commission could grant the requested deviation. Specifically, there were questions from Commission Staff regarding the amounts of the water usage reported and used in the calculations presented by Western Fleming in their Responses to Commission Staff's Second Request for Information ("Staff's Second Request").

The parties discussed the specific line items used by Western Fleming in their calculations for their Responses to Staff's Second Request and Western Fleming agreed to supplement their responses in an effort to provide a more accurate response. Western Fleming also agreed to supplement the reported water usage in their Annual Reports filed with the Commission. Finally, Western Fleming agreed to provide a clearer statement of their position that they should be granted a storage requirement deviation because Western Fleming's wholesale customers have adequate water storage to meet their customer demand. Western Fleming believes it should be granted a deviation from the storage requirements for the amount of water sold to its wholesale customers. Because this argument is one of first impression to Staff, and subsequently

the Commission, Staff recommended Western Fleming provide as much information as possible upon which the Commission could reasonably make a decision.

There being no further business, the informal conference adjourned.
