

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Northeast Woodford Water District as follows:


SECTION 1. That the District hereby accepts the rate of the Frankfort Water and Electric Plant Board and approves the raising of rates by a like amount to its customers.
