### ORDER

On October 31, 2008, in Case No. 2008-00032,<sup>1</sup> the Commission approved rates for Burkesville Gas Company, Inc. ("Burkesville") and provided for their further adjustment on a monthly basis in accordance with Burkesville's Purchased Gas Cost Adjustment ("GCA") clause. On June 1, 2013, Burkesville implemented a revision in its GCA clause through the Commission's tariff filing system to provide for quarterly adjustment of its rates.

On May 18, 2017, Burkesville filed its Gas Cost Recovery ("GCR") rate application with a proposed effective date of June 27, 2017.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

 Burkesville's notice includes revised rates designed to pass on to its customers its expected change in gas costs.

- 2. Burkesville's notice sets out an Expected Gas Cost ("EGC") of \$7.9556 per Mcf, which is a decrease of \$.2927 per Mcf from the previous EGC of \$8.2483 per Mcf.
- Burkesville's notice sets out no Refund Adjustment.
- 4. Burkesville's notice sets out a current quarter Actual Cost Adjustment ("ACA") of (\$.0140) per Mcf. Burkesville's total ACA is \$.0084 per Mcf, which is an increase of \$.3921 per Mcf from its previous total ACA of (\$.3837) per Mcf.
- 5. Burkesville's GCR rate is \$7.9640 per Mcf, which is an increase of \$.0994 per Mcf from the previous GCR rate of \$7.8646 per Mcf.
- 6. The rates proposed by Burkesville and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Burkesville on and after June 27, 2017.

#### IT IS THEREFORE ORDERED that:

- The rates proposed by Burkesville and set forth in the Appendix to this
   Order are approved for service rendered by Burkesville on and after June 27, 2017.
- 2. Within 20 days of the date of this Order, Burkesville shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
