## ORDER

On May 31, 2017, Dexter-Almo Heights Water District ("Dexter-Almo") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Dexter-Almo purchases water from the Murray Municipal Utilities ("Murray").
- 2. Murray notified Dexter-Almo on October 5, 2016 that its wholesale rate would increase from \$2.43 per 1,000 gallons to \$2.67 per 1,000 gallons effective July 1, 2017<sup>2</sup>. Dexter-Almo proposed to increase the water rates to its customers effective July 1, 2017, to reflect the increased cost of purchased water from Murray.
- 3. Dexter-Almo proposed a purchased water adjustment factor of \$0.27 per 1,000 gallons in its application, based on a calculation of its increased cost of water being \$0.2739 per 1,000 gallons. Dexter-Almo included proposed rates reflecting an increase of \$0.27 per 1,000 gallons. By letter, Dexter-Almo has subsequently requested to amend its application to propose a revised purchased water adjustment factor of \$0.28 per 1,000

gallons<sup>3</sup> to reflect a rounding up of its increased cost of purchased water, rather than its prior proposal to round down. However, Dexter-Almo did not file a revised schedule of rates to reflect the purchased water adjustment of \$0.28 per 1,000 gallons.

- 4. During the 12 months ended May 31, 2016, Dexter-Almo purchased 42,982,500 gallons of water from Murray. During the same period, Dexter-Almo sold 37,661,800 gallons of water. The increase in the cost of purchased water is \$10,315.80, resulting in a purchased water adjustment factor of \$0.28 per 1,000 gallons.
- 5. The purchased water adjustment factor of \$0.28 per 1,000 gallons, as calculated in Appendix A to this Order, permits Dexter-Almo to pass through the increase in its wholesale rates from Murray and is fair, just, and reasonable and should be approved.
- Dexter-Almo's proposed schedule of rates filed in the application should be denied.
- 7. The rates based on the \$0.28 per 1,000 gallon purchased water adjustment factor as set forth in Appendix B to this Order are fair, just and reasonable and should be approved for water service rendered by Dexter-Almo on and after July 1, 2017.

#### IT IS THEREFORE ORDERED that:

- The purchased water adjustment factor of \$0.28 per 1,000 gallons is approved.
  - 2. Dexter-Almo's proposed rates are denied.

- 3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Dexter-Almo on and after July 1, 2017.
- 4. Within 20 days of the date of this Order, Dexter-Almo shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
