ORDER

On September 1, 2017, Liz Childress filed a complaint on behalf of ResComm Security Systems ("ResComm"), a Kentucky Corporation, against Cincinnati Bell Telephone Company. On September 5, 2017, the Commission by letter acknowledged the receipt of the complaint. The Commission subsequently entered an Order dated September 12, 2017, rejecting the complaint for filing on the grounds that, pursuant to 807 KAR 5:001, Section 4(4), Ms. Childress cannot file a complaint on behalf of ResComm because she is not a licensed attorney.

The Commission granted ResComm ten days from the date of the Order to have an attorney licensed to practice law in the state of Kentucky file a signed complaint; failure to do so would result in the case being dismissed without prejudice. Both the Commision

letter and the September 12, 2017 Order were served on ResComm at the address on file with the Commission.

Having reviewed the evidence of record and being otherwise sufficiently advised, the Commission finds that ResComm has not filed a complaint signed by an attorney on its behalf and, pursuant to the September 12, 2017 Order issued in this case, ResComm's Complaint should be dismissed without prejudice.

IT IS THEREFORE ORDERED that: this case is dismissed without prejudice and is removed from the Commission's docket.
