ORDER

On October 21, 2010, in Case No. 2010-00116,¹ the Commission approved rates for Delta Natural Gas Company, Inc. ("Delta") and provided for their further adjustment in accordance with Delta's Gas Cost Adjustment clause.

On September 21, 2017, Delta filed its proposed Gas Cost Recovery ("GCR") application to be effective October 25, 2017.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Delta's notice includes revised rates designed to pass on to its customers its expected change in gas costs.
- Delta's notice sets out an Expected Gas Cost ("EGC") of \$4.1937 per Mcf,
 which is a decrease of \$1.1657 per Mcf from the previous EGC of \$5.3594 per Mcf.
 - Delta's notice sets out no Refund Adjustment.
- 4. Delta's notice sets out a current quarter Actual Adjustment ("AA") of \$.1961 per Mcf. Delta's total AA is \$1.1802 per Mcf, which is an increase of \$.1270 per Mcf from the previous total AA of \$1.0532 per Mcf.

 Delta's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0145) per Mcf. Delta's total BA is \$.1231 per Mcf, which is an increase of \$.1937 per Mcf from the previous BA of (\$.0706) per Mcf.

6. Delta's GCR rate is \$5.4970 per Mcf, which is a decrease of \$.8450 per Mcf from the previous GCR rate of \$6.3420 per Mcf.

7. The rates as proposed by Delta and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after October 25, 2017.

IT IS THEREFORE ORDERED that:

 The rates proposed by Delta and set forth in the Appendix to this Order are approved for final meter readings on and after October 25, 2017.

 Within 20 days of the date of this Order, Delta shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.
