# COMMONWEALTH OF KENTUCKY BEFORE THE PUBLIC SERVICE COMMISSION

#### ORDER

On February 16, 1995,<sup>1</sup> the Commission approved rates for Gasco Distribution Systems, Inc. ("Gasco") and provided for their further adjustment on a quarterly basis in accordance with its Gas Cost Adjustment clause. On February 28, 2011, Navitas KY NG, LLC ("Navitas KY") acquired the assets of Gasco, pursuant to the Commission's approval of the transfer, and adopted Gasco's tariffs.<sup>2</sup>

On October 10, 2017, Navitas KY filed its proposed Gas Cost Recovery ("GCR") rate application to be effective November 1, 2017.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

 Navitas KY's notice includes revised rates designed to pass on to its customers its expected change in gas costs.

- Navitas KY's notice sets out an Expected Gas Cost ("EGC") of \$7.0568 per
   Mcf, which is an increase of \$.6454 per Mcf from its previous EGC of \$6.4114 per Mcf.
  - Navitas KY's notice sets out no Refund Adjustment.
- 4. Navitas KY's notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$.2889 per Mcf. Due to a spreadsheet rounding error, Navitas KY erroneously set out an incorrect total ACA of \$.3931 per Mcf. Navitas KY's corrected total ACA is \$.3932 per Mcf, which is a decrease of \$.1132 per Mcf from its previous total ACA of \$.5064 per Mcf.
- 5. Navitas KY's notice sets out a current quarter Balance Adjustment ("BA") of (\$.0639) per Mcf. Navitas KY's total BA is (\$.1019) per Mcf, which is an increase of \$.3131 per Mcf from its previous total BA of (\$.4150) per Mcf.
- 6. Navitas KY's GCR rate is \$7.3481 per Mcf, which is an increase of \$.8453 per Mcf from its previous GCR rate of \$6.5028 per Mcf. Navitas KY's GCR rate required no correction due to a similar spreadsheet rounding error as occurred with the ACA calculation in adding the separate components of the rate.
- 7. The rate set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for service rendered by Navitas KY on and after November 9, 2017. Navitas KY did not provide the 30 days' notice required for its rate increase to become effective November 1, 2017.

#### IT IS THEREFORE ORDERED that:

 The rate set forth in the Appendix to this Order is approved for service rendered by Navitas on and after November 9, 2017. Within 20 days of the date of this Order, Navitas KY shall file with this
Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets
setting out the rate approved herein and reflecting that it was approved pursuant to this
Order.
