ORDER

On October 16, 2017, Northeast Woodford County Water District ("Northeast Woodford") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. By letter dated October 23, 2017, the Commission notified Northeast Woodford that its application was rejected as deficient. On November 14, 2017, Northeast Woodford filed to correct its filing deficiencies and its application was accepted for filing on November 15, 2017.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- Northeast Woodford purchases water from Frankfort Electric & Water
 Plant Board ("Frankfort") and the city of Versailles ("Versailles").
- 2. Frankfort, pursuant to a previous Commission Order, increased its rate to Northeast Woodford effective November 1, 2017, from \$2.45 per 1,000 gallons to \$2.55 per 1,000 gallons.² Northeast Woodford proposed to increase the water rates to its

customers effective November 12, 2017, to reflect the increased cost of purchased water.

- Northeast Woodford, in its application, proposed a purchased water adjustment factor of \$0.04 per 1,000 gallons.
- 4. During the 12 months ended on August 31, 2017, Northeast Woodford purchased 48,898,500 gallons of water from Frankfort and 96,049,900 gallons from Versailles. During the same period, Northeast Woodford sold 141,098,000 gallons of water. The increase in the cost of purchased water is \$4,889.85, resulting in a purchased water adjustment factor of \$0.04 per 1,000 gallons.
- The proposed purchased water adjustment factor of \$0.04 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.
- 6. Northeast Woodford's proposed rates, as set forth in Appendix B to this Order, are fair, just, and reasonable and should be approved for water service rendered by Northeast Woodford on and after November 12, 2017.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment factor of \$0.04 per 1,000 gallons is approved.
- The rates as set forth in Appendix B to this Order are approved for water service rendered by Northeast Woodford on and after November 12, 2017.
- Within 20 days of the date of this Order, Northeast Woodford shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
