<u>ORDER</u>

This matter arises upon the motion of wireless eligible telecommunications carriers (collectively, "Wireless ETCs") Airvoice Wireless, American Broadband and Telecommunications Company, Boomerang Wireless, i-wireless LLC, Ready Wireless, SI Wireless, LLC and Telrite Corporation, filed February 14, 2018, for full intervention. It appears to the Commission that such intervention is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, finds that the motion should be granted.

IT IS HEREBY ORDERED that:

1. The motion of the Wireless ETCs to intervene is granted.

2. The Wireless ETCs shall be entitled to the full rights of a party and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by parties after the date of this Order.

3. The Wireless ETC's shall comply with all provisions of the Commission's regulation, 807 KAR 5:001, Section 7, related to the service and filing of documents.

4. Wireless ETCs shall adhere to the procedural schedule set forth in the Commission's February 2, 2018 Order and as amended by subsequent Orders.

5. Within seven days of entry of this Order, the Wireless ETC's shall provide the electronic mail address to which all electronic documents issued by the Commission and other parties of record may be served upon the Wireless ETC's in accordance with 807 KAR 5:001, Section 4(8).
