ORDER

On February 16, 1995,¹ the Commission approved rates for Gasco Distribution Systems, Inc. ("Gasco") and provided for their further adjustment on a quarterly basis in accordance with its Gas Cost Adjustment clause. On February 28, 2011, Navitas KY NG, LLC ("Navitas") acquired the assets of Gasco, pursuant to the Commission's approval of the transfer, and adopted Gasco's tariffs.²

On December 27, 2017, Navitas filed its proposed Gas Cost Recovery ("GCR") rate application, to be effective February 1, 2018.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

1. Navitas's notice includes revised rates designed to pass on to its customers

its expected change in gas costs.

2. Navitas's notice sets out an Expected Gas Cost ("EGC") of \$7.4535 per Mcf, which is an increase of \$.3967 per Mcf from its previous EGC of \$7.0568 per Mcf.

3. Navitas's notice sets out no Refund Adjustment.

4. Navitas's notice sets out a current quarter Actual Cost Adjustment ("ACA") of \$.0744 per Mcf. Navitas's total ACA is \$.3881 per Mcf, which is a decrease of \$.0051 per Mcf from its previous total ACA of \$.3932 per Mcf.

5. Navitas's notice sets out a current quarter Balance Adjustment ("BA") of \$.0052 per Mcf. Navitas's total BA is (\$.0988) per Mcf, which is an increase of \$.0031 per Mcf from its previous total BA of (\$.1019) per Mcf.

 Navitas's GCR rate is \$7.7428 per Mcf, which is an increase of \$.3947 per Mcf from its previous GCR rate of \$7.3481 per Mcf.

7. The rate set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for service rendered by Navitas on and after February 1, 2018.


IT IS THEREFORE ORDERED that:
