MOTION FOR AN EXTENSION OF TIME


Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by counsel, and moves the Kentucky Public Service Commission ("Commission") for an Order extending the deadline by which EKPC must file its direct testimony and its responses to the requests for information contained in Appendix B of the Commission's Order entered herein on February 6, 2017. Specifically, EKPC requests that it be allowed an additional four (4) days (*i.e.*, until Friday, February 24, 2017) to file its direct testimony and responses.

In support of this Motion, EKPC states that additional time is necessary in order to adequately review, compile and confirm the extensive information and voluminous documentation EKPC must provide pursuant to the Commission's February 6, 2017 Order. While EKPC endeavors to provide its direct testimony and its responses to the Commission's forty-two (42) individual requests for information (excluding subparts) as soon as practicable, the relatively brief extension of time prayed for herein is reasonable and will not result in prejudice or undue delay.

WHEREFORE, for good cause shown, EKPC respectfully requests an Order from the Commission extending to February 24, 2017, the deadline by which EKPC must file direct testimony and responses to the requests for information propounded in the February 6, 2017 Order.
