My name is Rosanne Walton and I am listed as the Sole Member of Beaver Telecom, LLC, Utility ID: 5056760. My phone # is (

I received an Order from the Public Service Commission saying that I had failed to file reports of gross earnings or receipts derived from intrastate business for the years of 2014 and 2015. I was unaware of this requirement and the person who opened this company was supposed to file any reports necessary for the State of Kentucky. I gave this man a significant amount of money to take care of all the details because I know absolutely nothing about the telecom business. He was to run the business and share the profits with me. As is probably obvious to you by now, this whole arrangement was nothing but a scam. No customers were ever set up or served in any way. No income was ever received.

I sent in the paperwork that I had requested from the State of Kentucky so that I would be sure that company would be properly closed with the State. I thought that the paperwork I sent to Kentucky would close the company so that I would have no further responsibilities to the State.

Apparently, unbeknownst to me, I, apparently, still have obligations to the State of Kentucky, as per your Order.

I have paid out a considerable amount of money to have all of these matters handled but have not received any income from this company. The company never actually operated in the State of Kentucky. It was set up and then ignored by the person who took my money but never delivered on any of his promises.

In order to explain more, as to how I have found myself in this position, I must tell you that I have been quite ill for some time and I have learned that my brain was impacted by a yearlong medical treatment I had undergone prior to investing with this scam artist. I realized that something was very wrong when I saw that I could not perform my job to meet my own high standards, all due to the damage done by the medical treatment I had received. My direct boss, the President of the company, believed that I would improve with time, however, I decided to resign from my position as the Purchasing Director for this relatively large Houston homebuilder, after 17 years. In summary, I have also managed a number of residential and commercial purchasing departments over a more than 30 year period. I am not complaining nor do I want to sound like I am whining. I do want to be sure that you understand that I have made decisions regarding any involvement with the State of Kentucky, based on misinformation given to me by a person who ended up being a scam artist. Very importantly, I did not know how much my brain had been impaired by the medical treatment I received. I can only hope that you can understand that my physical and mental condition has attributed to the predicament that I am apparently in, with regard to the State of Kentucky. My memory is very poor so, if I ever received requests for the missing reports, I do not recall receiving such information.

I only want to close Beaver Telecom, LLC in the proper fashion, which I believed I had done some time ago, using the paperwork that I received from the State.

Any help or guidance you can provide to me would be greatly appreciated. I want to do the right thing with regard to Kentucky. At this point, I don't know what I need to do to assure that I have successfully closed the company. I am not in a financial position to pay fines, penalties, etc. I have not received any income nor has the company ever actually operated in the State of Kentucky. Further, I had believed that I had submitted the necessary paperwork to properly close this company.
