Pursuant to a Commission Order issued on March 8, 2017, an informal conference was held on March 22, 2017, at the Commission's offices in Frankfort, Kentucky. The purpose of the informal conference was to discuss any and all issues related to the instant show cause proceeding against Inter-County Cooperative Corporation ("Inter-County"). A list of the attendees is attached hereto.

Commission Staff began the meeting by stating that the purpose of the informal conference was to discuss the show cause proceeding against Inter-County. Giving rise to the show cause proceeding is the November 23, 2015 incident involving Inter-County employee, Colby Grider.

Commission Staff and representatives of Inter-County discussed the incident, including any remedial measures taken by Inter-County to address safety concerns. Commission Staff and Inter-County were able to reach an agreement in principal. Commission Staff will prepare a draft of the Stipulation and Settlement Agreement and will forward to counsel for Inter-County to review.

There being no further discussions, the informal conference was adjourned.
