## NOTICE OF ELECTION OF USE OF ELECTRONIC FILING PROCEDURES

(Complete All Shaded Areas and Check Applicable Boxes)

In accordance with 807 KAR 5:001, Section 8, Louisville Gas and Electric Company gives notice of its intent to file an application for Order Authorizing Issuance of Securities with the Public Service Commission no later than February 27, 2017 and to use the electronic filing procedures set forth in that regulation.
