RE: Informal Conference of May 3, 2017

Pursuant to the Commission's April 12, 2017 Order, an informal conference ("IC") was held in this matter on May 3, 2017. Attached is a copy of the attendance roster.

Commission Staff began the meeting by stating that the purpose of the conference was to discuss the show cause proceeding against East Kentucky Power Cooperative ("EKPC"). Giving rise to the show cause proceeding is the April 7, 2016 incident involving Dustin Cody Kidd.

Commission Staff and EKPC discussed the incident, including remedial measures taken by EKPC to address safety concerns. Commission Staff requested that EKPC file documentation of its remedial measures into the record. Commission Staff and EKPC reached an agreement in principle and will prepare to draft a Stipulation Agreement.

There being no further issues to discuss, the conference was adjourned.
