Pursuant to a Commission Order issued on April 21, 2017, an informal conference was held on May 2, 2017, at the Commission's offices in Frankfort, Kentucky. The purpose of the informal conference was to discuss issues related to the instant show cause proceeding against South Kentucky Rural Electric Cooperative Corporation ("South Kentucky"). A list of the attendees is attached hereto.

Commission Staff began the meeting by stating that the purpose of the informal conference was to discuss the show cause proceeding against South Kentucky, which was initiated in response to the August 12, 2016 incident involving South Kentucky employee, Byron Koontz. Commission Staff and representatives of South Kentucky discussed the incident and remedial measures taken by South Kentucky to address safety concerns. Commission Staff and South Kentucky were able to reach an agreement in principal. Commission Staff will prepare a draft Stipulation and Settlement Agreement and will forward it to counsel for South Kentucky for review.

There being no further discussions, the informal conference was adjourned.
