MOTION FOR LEAVE TO PUBLISH NOTICES OUT OF TIME IN THE LESLIE COUNTY NEWS AND THE TROUBLESOME CREEK TIMES

Kentucky Power Company moves the Public Service Commission of Kentucky pursuant to 807 KAR 5:011, Section 15 for leave to publish in the Leslie County News on March 23, 2017 and March 30, 2017 the second and third publications of the notice required by 807 KAR 5:011, Section 8(4). The Company further seeks leave to publish in the Troublesome Creek Times (Knott County) on March 23, 2017 the third publication of the notice required by 807 KAR 5:011, Section 8(4). Kentucky Power states in support of its motion:

- 1. Kentucky Power proposed to publish the notice required by 807 KAR 5:011, Section 8(4) in the newspapers of record in each of the twenty counties in its service territory during the weeks of February 27, 2017, March 6, 2016, and March 13, 2017.
- 2. The Leslie County News is the newspaper of record for Leslie County, Kentucky. It is published on Thursday of each week.
- The Troublesome Creek Times is the newspaper of record for Knott County,
 Kentucky. It is published on Thursday of each week.
 - 4. The Kentucky Press Service, acting on behalf of Kentucky Power, contacted the

Leslie County News and the Troublesome Creek Times and arranged for the notice required by 807 KAR 5:011, Section 8(4) to be published in each newspaper on March 2, 2017, March 9, 2017, and March 16, 2017.

- 5. The Kentucky Press Service contacted the Leslie County News on March 15, 2017 to confirm the notice was published as scheduled on March 2, 2017 and March 9, 2017, and that it would be published on March 16, 2017. The Kentucky Press Service was notified by the Leslie County News on March 16, 2017 that the notice was published on March 2, 2017 by the Leslie County Times but, because of staffing issues at the newspaper, the notice was not published on March 9, 2017 and would not be published on March 16, 2017.
- 6. Kentucky Power was informed by the Kentucky Press Service on March 17, 2017 that the required notice was published on March 2, 2017 and March 9, 2017 by the Troublesome Creek Times. Kentucky Power is further informed by the Kentucky Press Service that the notice scheduled to be published on March 16, 2017 in the Troublesome Creek Times was published but was illegible.
- 7. Kentucky Power is informed by the Kentucky Press Service that the second and third required publications in the Leslie County News of the notice are now scheduled to be published on March 23, 2017 and March 30, 2017. Kentucky Power is further informed by the Kentucky Press Service that the third required publication of the notice in the Troublesome Creek Times is scheduled to be republished on March 23, 2017.
- 8. The Kentucky Press Service confirmed to Kentucky Power on March 20, 2017 that the required notices had been published as scheduled in the remaining 18 newspapers of record in the Company's service territory.
 - 9. Kentucky Power exercised due care in arranging through the Kentucky Pres Service

for the publication of the notice in the Leslie County News and the Troublesome Creek Times. Kentucky Power relied in good faith on the commitments by the Leslie County News and the Troublesome Creek Times to publish the notices on March 9, 2017 and March 16, 2017 and March 16, 2017 respectively.

- 10. Under the modified publication schedule the residents of Leslie County will receive notice through publication in the Leslie County News of the proposed tariffs two times prior to the original requested effective date¹ of the tariffs.
- 11. Under the modified schedule residents of Knott County will receive notice through publication in the Troublesome Creek Times of the proposed tariffs three times prior to the original requested effective date of the tariffs.

WHEREFORE, Kentucky Power Company respectfully requests the Public Service Commission of Kentucky enter an order:

- (1) Granting it leave to publish in the Leslie County News on March 23, 2017 and March 30, 2017 the second and third notices required by 807 KAR 5:011, Section 8(4);
- (2) Granting it leave to publish in the Troublesome Creek Times on March 23, 2017 the third notice required by 807 KAR 5:011, Section 8(4); and
 - (3) Granting all other required relief or approvals.

¹ The Company requested an effective date of March 25, 2017 in its application. Kentucky Power notified the Commission on March 9, 2017 that it did not object to the request by a party to this case that the effective date be delayed to April 2, 2017. The Company anticipates the notice will be published in the Leslie County News three times prior to the effective date of the tariffs if the effective date is delayed to April 2, 2017.
