1 MS. VINSEL: My name is Nancy
2 Vinsel. I'm a staff attorney with the
3 Kentucky Public Service Commission. Today is
4 June 28th.

5 By mutual agreement, a deposition
6 had been scheduled to take the testimony of
7 Basil Pollitt in PSC case number 2017-120.
8 This is a case styled Pollitt Enterprises,
9 Inc., Whitney Clark Pollitt, Individually,
10 Amanda Deeann Pollitt, Individually, and
11 Basil C. Pollitt, Individually, d/b/a The Gas
12 Group, Inc., a/k/a The Gas Group.

13 There is an allegation that since
14 2006 these individuals have been operating a
15 natural gas distribution system serving
16 retail customers. It should be subject to
17 the Commission's jurisdiction. They have not
18 filed a CPCN to provide utility service.
19 They have not filed a tariff of rates. They
20 have not filed annual reports.

21 On June 15th, 2017, the Commission
22 issued a subpoena to Basil C. Pollitt to
23 appear today for the deposition. He was also
24 to produce certain documents. This was
25 served by registered mail. The Commission

1 also issued a subpoena duces tecum to Whitney
2 Clark Pollitt to produce certain documents,
3 including federal tax returns, state tax
4 returns, sample customer bills, and an
5 operations and maintenance plan for this gas
6 system. At the close of business yesterday,
7 counsel for the Pollitts indicated he had
8 filed motions in Franklin Circuit Court,
9 including one to quash Whitney Clark
10 Pollitt's subpoena, and indicated that
11 today's deposition would be rescheduled. In
12 response, I informed counsel that I would be
13 here to take the deposition of Basil Pollitt
14 as scheduled. And that's what I am here for
15 today. Mr. Hoskins, the counsel, and Basil
16 Pollitt have not appeared.

17 I would like to introduce a few
18 items as exhibits into the record. The
19 first is the subpoena that was issued to
20 Basil C. Pollitt. I will call that No. 1;
21 Deposition Exhibit No. 2 is a subpoena duces
22 tecum that was issued to Whitney Clark
23 Pollitt. Exhibit No. 3 is records provided
24 by the Kentucky Division of Oil and Gas. And
25 these show all well permits that have been

1 issued to anyone by the name of Pollitt or
2 The Gas Group. There are seven permits, all
3 are issued to Pollitt Enterprises, Inc. and
4 show an address of 12004 Ridge Road,
5 Louisville, Kentucky 40223. The next item,
6 exhibit to be introduced, Exhibit No. 4 is a
7 certified copy from the Kentucky Secretary of
8 State showing the Articles of Incorporation
9 of Pollitt Enterprises, Inc., which was filed
10 in January of 2006. It shows that W. Clark
11 Pollitt was the initial registered agent, is
12 also the CEO and incorporator, and Amanda D.
13 Pollitt listed as an incorporator. And has a
14 document filed in September 2006, a statement
15 of change of principal office address for
16 Pollitt Enterprises, Inc. from 12004 Ridge
17 Road, Anchorage, Kentucky to a Florida
18 address, 24418 Mistwood, M-i-s-t-w-o-o-d,
19 Court, in Lutz, Florida, L-u-t-z. Upon
20 information and belief, this is the address
21 of Amanda Deeann Pollitt.

22 The Commission has Exhibit No. 5,
23 which is a certified list of active operators
24 as of June 9th, 2007. This was provided by
25 the Kentucky Division of Oil and Gas. The

1 Pollitt Enterprises, Inc. is the only active
2 operator that includes the name Pollitt. Its
3 address is listed as 12204 Ridge Road,
4 Anchorage, Kentucky. There are no listings
5 for Basil Pollitt or The Gas Group in any
6 version of those names. Last I have two more
7 documents showing pipeline markers. The
8 first will be Exhibit No. 6. This shows
9 photographs, several exhibits that were
10 introduced in a case before the Commission,
11 case number 99-130. Of particular note is
12 Staff Exhibit 7, which shows a gas pipeline
13 for the natural gas distribution system that
14 is the subject of this matter, and it shows
15 in case of emergency to contact The Gas Group
16 with an 800 number. Last, I have a
17 photograph of a similar pipeline marker on
18 that same system undated, but it now lists
19 the pipeline as owned by Pollitt Enterprises,
20 Inc. and provides a telephone number that
21 starts with area code 270.

22 And that completes the session for
23 today.
