OBJECTION TO SUBPOENA ISSUED TO JASON SHARP

Come the Respondents, The Gas Group/Basil Pollitt, by counsel, and do hereby object to the subpoena issued to Jason Sharp, Registered Agent of Southern Kentucky Energy, LLC, and in support of same state as follows:

A subpoena was issued and "served" electronically upon Jason Sharp. The subpoena indicates it is served on Sharp in his capacity as the registered agent of Southern Kentucky Energy. The subpoena itself however indicates that it is directed at Sharp in his individual capacity as a fact witness.¹ The subpoena was issued and "served" electronically on 8-7-17 at 4:12 p.m. and commands Sharp's appearance at a hearing scheduled for 8-9-17 at 9:00 a.m. in Frankfort, KY. The Gas Group verily believes that Sharp is not a Kentucky resident thus there is no authority to command his appearance via a subpoena. Moreover, the time available to Sharp to comply with the subpoena is unreasonable. Finally, there is no basis for service of a subpoena on a non party via electronic means. The subpoena represents to Sharp that his attendance/compliance is required when there is not authority for this. For these reasons Pollitt objects to the 11th hour subpoena.
