Pursuant to a Commission Order issued on May 5, 2017, an informal conference was held on May 17, 2017, at the Commission's offices in Frankfort, Kentucky. The purpose of the informal conference was to discuss any and all issues related to the instant show cause proceeding against Owen Electric Cooperative, Inc. ("Owen Electric"). A list of the attendees is attached hereto.

Commission Staff began the meeting by stating that the purpose of the informal conference was to discuss the show cause proceeding against Owen Electric. Giving rise to the show cause proceeding is the January 20, 2017 incident involving Owen Electric employee, Brian Noel.

Commission Staff and representatives of Owen Electric discussed the incident, including any remedial measures taken by Owen Electric to address safety concerns. Commission Staff and Owen Electric were able to reach an agreement in principal. Commission Staff will prepare a draft of the Stipulation and Settlement Agreement and will forward to counsel for Owen Electric to review.

There being no further discussions, the informal conference was adjourned.
