## **DATA REQUEST 1**

Refer to the cover letter of the Application.

a. Provide details supporting the referenced improvement in the Belfry system Lost and Unaccounted for gas "(L&U)" projections, as well as the history of L&U improvement in that portion of Frontier's system.

b. Provide details concerning the Pipeline Replacement Program budget overruns.

c. Provide a discussion of the likelihood that Frontier's system-wide L&U will be reduced to 5 percent or below by the end of this year.

#### **RESPONSE:**

- (a) Approximately 8,000 feet of steel pipe was replaced with plastic pipe in the Belfry system during the 2016 construction season. This has resulted in a slight L&U improvement. The Belfry 2016/2017 heating season (October through February) L&U was reduced by 4,200 MCF compared to the Belfry 2015/2016 heating season.
- (b) KFG's spent \$118,682 on the 2016 PRP. KFG's 2016 cost recovery through the PRP program was \$53,486. This resulted in a \$65,196 overrun of KFG's PRP budget.
- (c) Frontier's system-wide L&U will not be reduced to 5 percent or below by the end of this year. Pipe replacement will primarily be in the Belfry system for the remainder of 2017. Frontier has revised its estimate for system-wide L&U to 10% by the end of 2017.

Refer to Schedule II. Confirm that Nytis (Auxier) rate should be \$2.4682 instead of \$3.053.

#### **RESPONSE:**

The Nytis contract price for Auxier gas supply is 100% of TCo First of the Month (FOM), or \$3.0853. The Nytis contract price for Sigma gas supply is 80% of TCo FOM, or \$2.4682.
