ORDER

On August 28, 2017, Kentucky Power Company (“Kentucky Power”) filed a motion requesting a deviation from a requirement set forth in the Commission’s April 27, 2017 Order that Kentucky Power file with the Commission an original and six copies in paper medium of all documents filed electronically in this case. As a basis for this request, Kentucky Power states that six documents filed as attachments to Kentucky Power’s responses to the Attorney General’s First Request for Information (“Attorney General’s First Request”) are too voluminous to produce in paper form.

Kentucky Power requests to file the below items on compact disc in lieu of the required paper original and six paper copies.

- Kentucky Power’s response to Attorney General’s First Request, Item 20, Attachment 1, which consists of vegetation management contracts that total approximately 1,500 pages.

- Kentucky Power's response to Attorney General's First Request, Item 42, Attachments 1, 2, and 4, which consist of general ledger documents that total over 8,000 pages.

Kentucky Power also requests to file the original of the below items in paper medium and the requisite six copies of the below items on compact disc:

- Kentucky Power's response to Attorney General's First Request, Item 42, Attachment 3, which consists of general ledger documents that total 680 pages.

- Kentucky Power's response to Attorney General's First Request, Item 44, Attachment 1, which consists of Kentucky Power's accounting manuals that total 623 pages.


Having carefully considered the petition and the materials at issue, the Commission finds that Kentucky Power has shown good cause to permit it to deviate from the filing requirements contained in the April 27, 2017 Order. The Commission further finds that Kentucky Power's request for deviation to file the designated materials in electronic medium should be granted.

IT IS THEREFORE ORDERED that Kentucky Power's motion to deviate from filing requirements of the April 27, 2017 Order is granted.
