Motion For Ten-Day Extension And Waiver Of Mail Service

Kentucky Power Company moves the Public Service Commission of Kentucky for a tenday extension until June 30, 2017 in which to file its written response to the allegations contained in the Staff Report. The response is due June 20, 2017.

Kentucky Power requests the brief extension in light of the demand on its resources in connection with its ongoing preparation of its application in Case No. 2017-00179 since the May 31, 2017 Order was entered, and to enable Kentucky Power to consult with the Company's legal counsel in the related civil action, *Estate of Tony Wayne Craig, Jr. v. Kentucky Power Company*, 16-CI-00470 (Greenup Circuit Court). The extension also will allow Kentucky Power to reexamine in light of the show cause order the more than 110 pages of investigative materials attached to the show cause order.

This motion is not made for purposes of delay.
