ORDER

On August 30, 2017, Central City Municipal Water & Sewer ("Central City") filed with the Commission a motion for withdrawal of its proposed wholesale rate increase. In support of the motion, Central City states that on April 13, 2017, it filed a revised tariff sheet setting forth proposed adjustments to its existing rates for wholesale water service to Muhlenberg County Water District ("Muhlenberg") and Muhlenberg County Water District #3 ("Muhlenberg #3) with an effective date of May 31, 2017. On May 23, 2017, the Commission issued an Order establishing a case in order to perform an investigation into the reasonableness of the proposed rates. Central City asserts that it has recently identified improvement projects for its water system that will require financing, and the anticipated financing will potentially impact the wholesale rates that must be charged by Central City. Thus, Central City requests that the proposed wholesale rate increase be withdrawn at this time. Neither Muhlenberg nor Muhlenberg #3 have objected to Central City's motion.

The Commission, having reviewed the record and being otherwise sufficiently advised, finds that good cause exists to grant Central City's motion for withdrawal and

that this case should be closed. If Central City decides to refile its wholesale rate increase in the future, then a new case number will be assigned to the matter.

IT IS THEREFORE ORDERED that:

- 1. Central City's motion for withdrawal is granted.
- 2. This matter is closed and removed from the Commission's docket.
