Purchased Water Adjustment Regulation 807 KAR 5:068

Dear Ms. Mathews:

The North Shelby Water Company respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The Company was recently notified by its supplier, Louisville Water Company, that it will increase meter service charges by \$28.50 per month and wholesale rates by \$0.05 per 1000 gallons. These increases will take effect July 1, 2017. The Company was also notified in December 2016, by another supplier, the Shelbyville Municipal Water & Sewer Commission, that it would increase its wholesale rates by \$0.066 per 1000 gallons. This increase took effect on January 19, 2017. The combined result of these increases is \$21,080.74 in additional yearly supply cost for the Company. This translates into \$0.06 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.

The monthly bill for a customer using an average of 5,000 gallons of water each month will increase from \$42.24 to \$42.54. This is an increase of \$0.30 or 0.71%.
