RE: Informal Conference of September 15, 2017

Pursuant to a Commission Staff ("Staff") September 14, 2017 Notice of Informal Conference ("IC") a telephonic IC was held in this matter on September 15, 2017, at the Commission's office in Frankfort, Kentucky. A list of attendees is attached hereto.

At the IC, Staff discussed Kentucky Frontier Gas, LLC's (Kentucky Frontier) responses to Staff's Requests for Information ("Responses"). Kentucky Frontier confirmed how it is prioritizing replacement of its pipe under its Pipeline Replacement Program, and that it could provide details concerning pipe yet to be replaced and related expenditures. Staff discussed further issues in follow-up to Kentucky Frontier's Responses that will be reflected in Staff's Third Request for Information, to be entered into the record September 22, 2017.
