Pursuant to a Commission Staff ("Staff") Notice, a telephonic informal conference ("IC") was conducted at the Commission's offices in Frankfort, Kentucky on September 7, 2017. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss certain filing deficiencies in Duke Energy Kentucky, Inc.'s ("Duke Kentucky") application for, among other things, an adjustment of electric rates. At the outset of the IC, Commission Staff noted that a deficiency letter was issued earlier in the day identifying the specific deficiencies noted by Commission Staff in its review of the application. During the IC, Commission Staff discussed the identified filing deficiencies in detail with Duke Kentucky.

Regarding the deficiencies related to the customer notice, Commission Staff noted that, assuming all other deficiencies were cured prior to that date, deeming the deficiency cured upon the first publication of the supplemental notices in a newspaper of general circulation in the utility's service area would be consistent with the regulation governing publication of customer notice. Duke Kentucky stated that it would aim to submit the revisions to correct the deficiencies within the next 10 days at the latest; revise the customer notice scheduled to be published next week; and have the corrected customer notice published by the following week at the earliest.

There being no further discussion, the IC was then adjourned.
