1. The Applicant, Meade County Water District (the "Applicant") respectfully tenders this Application, pursuant to KRS 278.023, 807 KAR 5:069, and all other applicable laws and regulations, and requests that the Public Service Commission of Kentucky (the "Commission") issue an Order:
 - a. granting a Certificate of Public Convenience and Necessity authorizing the Applicant to construct major additions and improvements to its water system (the "Project") for the purpose of increasing its water transmission capacity to both its wholesale and retail customers;
 - b. approving the proposed adjustment of water rates and charges to be levied and collected by the Applicant; and
 - c. authorizing the issuance of certain securities by the Applicant.
