15	confidential treatment and ten copies of that material with the confidential
16	information redacted.
17	2. Big Rivers is filing with this motion a hardcopy original and ten paper
18	copies of responses to the Initial Requests for Information of Commission Staff, the
19	Attorney General, Kentucky Industrial Utility Customers, Inc. ("KIUC"), and Ben
20	Taylor and the Sierra Club.
21	3. Items 14, 40, and 52 of the Commission Staff's Initial Request for
22	Information, Item 8 of KIUC's Initial Request for Information, and Items 8, 14, 25,
23	and 41 of Sierra Club's Initial Requests for Information, all request modeling files
24	or Excel files. As such, Big Rivers' is providing those files in electronic form as
25	requested.

1	4. As such, Big Rivers requests a deviation from the requirement to
2	provide paper copies of these files. Further, most of these files contain confidential
3	information for which Big Rivers is seeking confidential treatment pursuant to the
4	accompanying petition for confidential treatment. Since these documents are
5	spreadsheets and modeling files, Big Rivers cannot redact the confidential material
6	from some of the files without making other cells in the spreadsheets or modeling
7	files unusable. As such, Big Rivers requests a deviation from the requirement to
8	provide ten copies of the confidential documents with the confidential material
9	redacted.
0	WHEREFORE, Big Rivers respectfully requests that the Commission enter
1	an order granting a deviation to Big Rivers from the above requirements.
