ANSWER AND MOTION TO DISMISS

Now comes the Defendant, Kentucky-American Water Company ("KAW"), and for its Answer to the Complaint in this matter, makes the following admissions, denials, statements and defenses.

- 1. In response to the statement in Paragraph (a) of the Complaint, KAW admits that Roger W. Parry is a KAW customer located at 3415 Woodside Way, Lexington, Kentucky 40502.
- 2. In response to the statement in Paragraph (b) of the Complaint, KAW admits that KAW's physical and business address is 2300 Richmond Road, Lexington, Kentucky 40502.
- 3. In response to the allegations in Paragraph (c) of the Complaint related to water usage information, KAW states and admits the water usage shown for all months in calendar year 2017 on the invoices attached collectively as Exhibit A. As indicated on those invoices, all meter readings for that usage were based on actual, not estimated, meter readings. That usage is also reflected in the table below:

As to the additional allegations in Paragraph (c) of the Complaint, KAW states that a KAW employee was at Mr. Parry's residence to inspect the meter (meter number 090739475N) on or about July 20, 2017 and that KAW removed that meter within the next several days at Mr. Parry's request. KAW replaced that meter with a different meter (meter number 17309744). KAW denies the allegation that it has not acted in accordance with its tariff. KAW denies any irregularity with meter that was removed (090739475N) or with the process of reading that meter. KAW states that high usage events and periods can and do occur for many and various reasons caused by issues on the customer's side of the meter. KAW is either without information sufficient to respond to the balance of the allegations, statements, and argument set

forth in Paragraph (c) of the Complaint, and, therefore, denies them. In any event, those allegations, statements, and arguments are not "material allegations" requiring a response under 807 KAR 5:001, Section 20(6)(a).

- 6. KAW states that the meter in place at the premises in question (meter number 090739475N) during the period of high usage was tested and that it met all applicable accuracy requirements. Therefore, KAW believes that the water meter readings in question are accurate and that the indicated amount of water did, in fact, pass through the meter. Therefore, Mr. Parry is liable to KAW for all amounts resulting from the indicated usage and his Complaint should be dismissed. Robert Young Family v. Southeastern Water Association, PSC Case No. 2006-00212, Order of January 25, 2007; Susan Spangler and Mark Lewis Farman v. Kentucky-American Water Company, PSC Case No. 99-109, Order of October 7, 1999; and Moore's Chapel A.M.E.

7. KAW denies each and every allegation in the Complaint not specifically admitted to be true herein.

WHEREFORE, KAW moves for an Order dismissing the Complaint and requiring Mr. Parry to submit payment for all amounts owed to KAW.

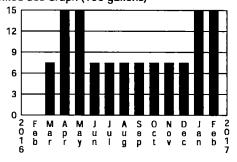

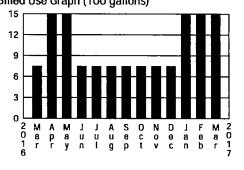

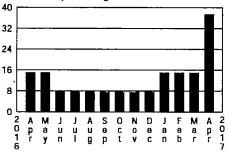

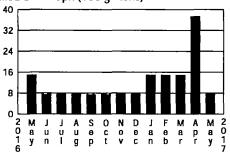

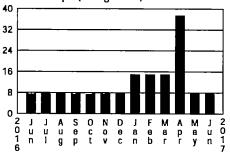

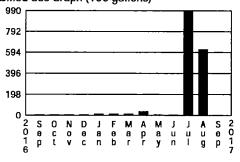

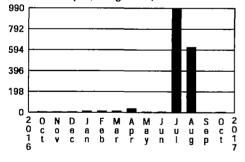

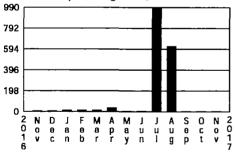

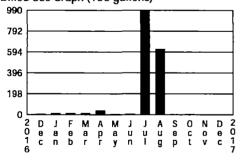

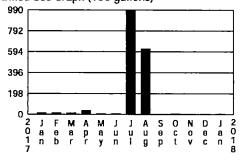
