COMMISSION STAFF'S FOURTH REQUEST FOR INFORMATION
TO CAWOOD WATER DISTRICT

Cawood Water District (Cawood District) pursuant to 807 KAR 5:001, is to file with the Commission the original and six copies in paper medium of the following information. The information requested herein is due within 14 days of the entry of this Request for Information. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed and shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Cawood District shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Cawood

District fails or refuses to furnish all or part of the requested information, it shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Cawood District shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Cawood District's June 19, 2018 response to Commission Staff's Third Request for Information, Item 3.e. Cawood District's Monthly Water Use Reports indicate a significant increase in system flushing for the months of March, April, and May 2018 when compared to the other months. Provide an explanation for the increase in system flushing.

2. Provide Cawood District's Monthly Water Use Report for June 2018.

3. Provide a list, by employee, that shows the number of overtime hours worked for the calendar year ended December 31, 2017.

4. State the amount of hourly compensation that Dalton Baker currently receives, and state whether he is a full-time or part-time employee.

5. Provide a list similar to the "Cawood Water District Employee List – Master" that was provided during the April 25, 2018 field review at Cawood District's Office, listing all of Cawood District's current employees and pay rates after the recent \$1.00 per hour raise was enacted.
